ADDENDUM

Sub: Amendment to Notification issued by the Board on Re-categorization of Industry/organization/activity as per the direction of CPCB - reg.

The Central Pollution Control Board vide ref (2) above had issued a direction under Section 18(1)(b) of the Water (Prevention & Control of Pollution) Act, 1974 for revising the list of Red, Orange and Green activities with a view to bring uniformity in classification across the entire country and for grant of consent, inventorization and other related activities.

The subject was discussed in the 184th Board meeting held on 17.7.2012 the Board approved to implement the direction and also resolved to constitute a technical committee as indicated in the directions.

Accordingly, Board has constituted a technical committee vide ref (1). The Committee has reviewed both the CPCB list as well as the existing KSPCB list and prepared a revised final list and issued Notification vide ref (2) & (6) and updated vide ref (7).

The Regional Officers namely Bangalore City East, Bangalore City West, Bangalore City South, Peenya, Belgaum-1, Gadag and SEO-NEIA-BO and few industries have sent proposal on categorization of activities which are not listed in the notification and clarity on certain specific activities. Technical committee in its meeting held on 17.03.2014 has discussed the issues and recommended in its proceedings to include certain activities to the list vide ref (8) and (9). The Board has authorized Chairman vide ref (4) to re-categorize the activities. Accordingly, the following categories to be included to the notified list cited under ref (2) and (6): -

Inclusion of activities under Red category after Sl. No.116			
1.	67	Metro train terminus (Depot).	This activity is similar to railway locomotive workshops/integrated road transport workshop/ authorized service centres, which is enlisted under RED (Sl No.67) and Hence, the said activity could be broadened by adding " Metro train terminus (Depot) activity " in Sl No.67 under RED category.
2	117	Reclaimed rubber	The reclaimed rubber processing activity is generating process emission and significant from air pollution point of view and " Reclaimed rubber manufacturing " activity could be enlisted under RED as new categorization.
3	118	Rubber Extrusion & Moulding Company.	The industry is engaged in manufacturing of rubber sheets involving mixing of synthetic rubber with steric acid, carbon black, process oil, zinc etc., in kneeder, sheeting, aging, extruding, curing, cooling, trimming and moulding. The industry is significant air pollution point of view and hence, the activity " manufacturing of Synthetic rubber profiles by extrusion and moulding " could be enlisted under RED as new categorization.

Inclusion of activities under Orange category after Sl.No.87

4	88	Washing and drying of natural rubber	The industry has submitted a letter by stating that the Washing and drying of natural rubber carried out without using chemicals. Since the activity involves only cleaning and drying and hence, " Washing and drying of natural rubber " could be newly categorized under ORANGE
5	86	Garment stitching and enzyme washing activity	The existing activity involves garment stitching and enzyme washing activity and recycling the treated effluent for process by adopting zero discharge. Hence, the activity could be covered under ORANGE category vide Sl No. 86 (Garment- washing only) of updated re-categorization list up to 31.01.2014.
6	89	Cotton ginning with de-linting	The Industry is engaged in cotton ginning with De-linting activity and the process involves cotton ginning, seeds washing using sulfuric acid and lime power and generating waste water and this activity is not enlisted in CPCB category. Hence, " Cotton ginning with de-linting " activity could be newly categorized under ORANGE.
