State Level Environment Impact Assessment Authority- Karnataka in its meeting on 11th November 2015 has noticed instances of project proponents who have started construction/production activity based on the Consent for Establishment issued by KSPCB, even though they require prior Environmental Clearance under EIA Notification, 2006 and the amendments made thereon. Hence, the SEIAA directed the KSPCB under Section 5 of the Environment (Protection) Act, 1986 to issue CFE for all such projects attracting EIA Notification, 2006 and the subsequent amendments only after the submission of copy of “prior Environmental Clearance” issued in accordance with law. Accordingly, all the Officers of the Board are instructed to scrupulously follow the directions of the SEIAA with immediate effect. Application for CFE/CFEx for project attracting EIA Notification, 2006 shall be received in the Board (Help Desk of Head Office / Regional Offices) along with a copy of Environmental Clearance only.
