Sub: Payment Gateway facility in XGN Software for remittance of Consent fee under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 - reg.,

As you are aware, the Board has provided the facility for Online payment of Consent fee through Payment gateway i.e., Net Banking, Debit & Credit cards for the applications received through XGN Software. Vide Board's Circular dated: 02-09-2016 cited at reference(4), it was informed to all the Regional Officers to appraise/advise the Organisations about the above payment gateway facility.

It has been noticed that many organisations are approaching the head office for payment of Consent fee (for the applications received through XGN Software) through NEFT/ RTGS/ DD modes also. Since the option for recording details for the payment made through NEFT/ RTGS/ DD modes has been discontinued in XGN Software as per the circular cited at reference(4), you are once again informed to appraise Organisations to pay consent fee **through Net Banking, Debit & Credit cards modes only** but not through NEFT/ RTGS/ DD. (Please note that the remittance of any balance Consent fee can be made through NEFT/ RTGS/ DD till the facility for 'acceptance of Balance Consent fee' is developed in XGN Software). It is to be informed that to improve the facility, a second gateway is also being added shortly to facilitate Corporate Payment etc., **In case the Industry/ Organisation pays the Consent fee by RTGS/ NEFT mode, the same could be refunded following procedure.**

Please note that for any discrepancy related to the consent fee, the jurisdictional Regional officer will be held responsible.
