Sub: Implementation of Karnataka Solar Policy 2014-21 - reg. Ref: Proceedings of 197th Board Meeting held on 26.03.2015

Government of Karnataka has notified the Solar Policy 2014-2021 to harness the potential of solar resources and to achieve the 3% contribution from Solar Source out of total energy consumption. In the policy intiatives under consideration of Government of Karnataka to promote solar power projects, it has been proposed that the Solar PV projects shall be exempted from obtaining clearances of pollution control board. This matter was discussed in detail in the 197th Board Meeting held on 26.03.2015 and resolved to include Solar Power Projects of 5 MW and above capacity under the purview of Pollution Control Acts. Hence, the following order.

ORDER

Solar Power Projects of 5 MW and above capacity only to come under the purview of Pollution Control Acts.

In the list of re-categorization of industries / organizations / activities, Sl.No.75 under Green Category is modified as below:

"Renewable Wind power projects of all capacities, Solar power projects of 5 MW and above capacity and mini hydel power plants of < 25 MW capacity"

This order comes into force with immediate effect and until further orders.
