Hence, the following;

ORDER

The guarantee money being collected in various circumstances from the Industries/Organization as proof of intent to implement the pollution control measures is dispensed forthwith.

This order superceeds all other previous Orders/Office Memorandum/ Notifications / Circulars regarding collection of guarantee money/Bank guarantee.

This order will come into force from the date of issue of this Office Memorandum and remain in force till further orders.
