The Board in its 182<sup>nd</sup> meeting held on 24.1.2012 decided to make it mandatory for industries/ organizations to pay one/two/three/five years consent fee to get consent validity for one/two/five/ten years respectively depending on the category of industry viz., large/medium/small and Red/Orange/Green. Accordingly a notification was issued vide ref (3).

Some industries which are located in leased premises or those planning to shift or close their industries within a year have represented to the Board with a request to collect one year fee instead of payment of the mandatorily fixed periods vide notifications cited under ref (3) and (4).

The Board in its 186<sup>th</sup> meeting held on 28-12-2012 discussed the subject and approved the proposal of collecting one year consent fee in certain cases. In case of breach of agreement, the Board approved to initiate penal action. Hence the following order is issued:

## ORDER

The industries/organizations to pay consent fee for one year only in case where an industry / organization gives an undertaking that the industry is going to close / shift from the existing premises within one year by citing valid reason. The Regional Officer shall keep close watch on such industry/organization and in case of breach of agreement the proposal for filing case shall be sent to Board after expiry of the consent. The order is applicable to all categories of industries/organizations located in leased premises or planning to shift/close within one year.

The Order will be in force from the date of issue.
