M/s. E & E Recyclers is a dismantling and segregation of E-waste of quantity 300 MT/Annum. The unit was issued authorization and registration issued under E-Waste (Management and Handling) Rules, 2011 from 18.03.2013 to 30.06.2017 and 18.03.2013 to 30.06.2015 respectively.

The unit was inspected by regional officer on 24.12.2014 in response to the letter vide ref. (2) where in facility authority had informed their intension to shift the unit. The inspecting officer made following observation:

1. There was no activity during the inspection and door was found to be closed.
2. They have shifted at back side of the building instead of first floor. It appear that, the unit is not under operation from long time.
3. The industry had installed table for dismantling, fume exhaust with lip hood suction attached to cyclone dust collector. The same has been removed and kept aside.
4. No responsible person was available at the time of inspection and it was observed that the machineries have been relocated at the back side of the

- building within the same premises and no activity is being carried out
5. The proprietor was contacted over telephone and he informed that so far no activity has been started

In view of above observation the regional officer recommended to cancel authorization and registration issued under of E-Waste (Management and Handling) Rules, 2011. Hence the following order

**ORDER**

In exercise of power conferred under section 10 of the E-waste (Management and Handling) Rules, 2011, **Cancel** the Authorization issued to you vide ref (1).

In exercise of power conferred under section 10 of the E-waste (Management and Handling) Rules, 2011, **Cancel** the Registration issued to you vide ref (1).

M/s. E & E Recyclers located at 1<sup>st</sup> Floor, Plot No.:302, KIADB Industrial Area, Bommasandra-Jigani link Road, Bangalore has obtained consent for operation under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 for carrying out dismantling and segregation of e-waste of quantity 30 MT/A valid upto 30.06.17 vide ref,(1). The said unit has also obtained authorization and registration as per the provisions of E-Waste (Management and Handling) Rules, 2011.

Facility authority vide their letter dated 26.02.2014 reported that they are not in a position to operate the industry at first floor and hence shift the industry looking into safety and material movement.

The unit was inspected by regional officer on 24.12.2014 and following observation were made:

1. There was no activity during the inspection and door was found to be closed.
2. They have shifted at back side of the building instead of first floor. It appear that, the unit is not under operation from long time.

3. The industry had installed table for dismantling, fume exhaust with lip hood suction attached to cyclone dust collector. The same has been removed and kept aside.
4. No responsible person was available at the time of inspection and it was observed that the machineries have been relocated at the back side of the building within the same premises and no activity is being carried out
5. During inspection, the proprietor was contacted over telephone and he informed that so far no activity has been started

In view of above observation the regional officer recommended to withdraw consent under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981. Hence the following order

**ORDER**

In exercise of power vested with KSPCB under sec. 25(4)(b) of the Water (Prevention and Control of Pollution) Act, 1974, the Board hereby withdraw the consent issued to E&E recyclers located at First Floor, Plot No.302, Bommasandra Jigani Link Road, Bangalore-560015 and also cancels the consent issued under Sec.21(4) of the Air (Prevention and control of Pollution) Act, 1981.
